



## China Yuchai International Announces Results of Dividend Elections

SINGAPORE, July 12, 2017 /PRNewswire/ -- China Yuchai International Limited (NYSE: CYD) ("China Yuchai" or the "Company") announced today the results of stockholders' elections in relation to the dividend declared by its Board of Directors on May 24, 2017. The dividend of US\$0.90 per share of common stock for the financial year 2016 to be made either wholly in cash or in new shares of CYI's common stock ("Shares") at the option of the stockholder, will be paid on July 13, 2017 to shareholders of record at the close of business on June 7, 2017.

Based on the elections by Shareholders, the aggregate dividend will be paid in the form of approximately US\$34.7 million in cash and 99,790 Shares. The number of Shares to be issued per share of common stock was determined based on the volume weighted average trading prices of the Company's common stock on the New York Stock Exchange during the period from July 5 to and including July 7, 2017 which was US\$19.0329 per Share. Further to the issuance of 99,790 Shares pursuant to the dividend payment, the Company's outstanding shares of common stock will increase to 40,811,890.

Shareholders who did not make an election or failed to respond within the given timeline will receive the dividend entirely in cash. CYI will pay fractional shares in cash which was determined based on the volume weighted average trading prices of the Company's common stock on the New York Stock Exchange during the period from July 5 to and including July 7, 2017 which was US\$19.0329 per Share.
